- 1 The above results were reviewed by the Audit Committee and taken on record by the Board of Directors at its meeting held on 23rd July 2010.
- 2 The Company has made an investment of Rs. 1424.91 lakhs in a wholly owned subsidiary SRF Global B.V. during the quarter. Further, it has sold its investment in SRF Overseas Limited, a wholly owned subsidiary, to another wholly owned subsidiary i.e. SRF Tech Textile B.V. at a profit of Rs. 285.15 lakhs.
- 3 There were no investor complaints outstanding at the beginning and at the end of the quarter. The Company received 138 complaints during the quarter and all of them were resolved.
- 4 Previous period figures have been regrouped wherever necessary to conform to current quarter classifications.
