# Dabur Q1 profit down 6%

PRESS TRUST OF INDIA New Delhi, July 30

**HOMEGROWN FMCG MAJOR** Dabur India on Thursday reported a 6.18% decline in its consolidated net profit at ₹341.30 crore for the quarter ended June 30, due to lower revenue from operations. It had posted a net profit of ₹363.81 crore in the April-June period of the last fiscal.

Revenue from operations was down 12.90% to ₹1,979.98 crore, against ₹2,273.29 crore in the corresponding quarter of the previous fiscal, Dabur India said in a BSE filing.

"We entered this crisis from a position of strength. We were growing at a steady pace when the Covid pandemic brought business to a standstill. Amidst this challenging business environment, we quickly revamped our portfolio to meet

the growing consumer need for quality...Dabur has significantly ramped up capacity with production now at near-normal levels and the business poised to deliver growth for the rest of the year," said Dabur India CEO Mohit Malhotra.

Dabur said during the quarter the company introduced a record number of new products and variants anchored on the consumer need for health, immunity and

### Bribery charges: Delhi High Court summons HP India, US parent

THE DELHI HIGH Court on Thursday issued summons to information technology major Hewlett Packard India Sales and its California-based parent HP Inc on the charges of indulging in "corrupt" and "unethical practices" in bribing officials to secure government projects and tenders.

Justice V Kameswar Rao also issued summons to its ex-MD Sumeer Chandra, currently working as company director, in Intel. Summons has also been issued to the chief HR officer, global compliance programme manager, Asia Pacific Japan HRER/HR compliance, among others.

The HC asked the respondents to file their reply within four weeks to the allegations by whistleblower Manoj Grover, a former employee of HP India. It also posted the matter for further hearing on September 21.

## Piramal posts 11% jump in Q1 net profit

PIRAMAL ENTERPRISES ON Thursday reported a 10.57% rise in consolidated net profit at ₹495.56 crore for the quarter ended June 30.

The company had posted a

net profit of ₹448.17 crore in the corresponding period of previous fiscal, Piramal Enterprises said in a filing to the BSE. Consolidated revenue from operations stood at ₹2,937.34 crore during the quarter under review against ₹3,186.82 crore in the same period a year ago, it added.

"We have delivered a resilient performance in Q1 with 11% y-oy net profit growth to ₹496 crore during the quarter, we substantially enhanced our liquidity position and strengthened our balance sheet," Piramal Enterprises chairman Ajay Piramal said.

Despite the slowdown caused by the pandemic, the company signed an agreement with global investment firm Carlyle to raise strategic growth investment of \$490 million in Piramal Pharma.



# सोनिया के साथ बैठक में उठी राहुल को फिर से अध्यक्ष बनाने की मांग

नई दिल्ली, 30 जुलाई (भाषा)।

कांग्रेस अध्यक्ष सोनिया गांधी ने गुरुवार को पार्टी के राज्यसभा सदस्यों के साथ वीडियो कॉन्फ्रेंस के जरिए बैठक की, जिसमें कई सदस्यों ने राहल गांधी को फिर से पार्टी अध्यक्ष बनाए जाने की मांग की।

पार्टी सूत्रों के मुताबिक, इस बैठक में रिपुन बोरा, पीएल पूनिया, छाया वर्मा तथा कुछ अन्य सदस्यों ने राहुल को फिर से पार्टी की कमान सौंपने की पैरवी की। बैठक से अवगत एक सूत्र ने बताया कि बोरा, पूनिया, छाया वर्मा और कुछ अन्य सदस्यों ने कहा कि मौजुदा समय में पार्टी कार्यकर्ताओं की भावना है। कि राहुल गांधी को फिर से कांग्रेस अध्यक्ष बनाया जाए। इन्होंने यह भी कहा कि राहुल गांधी ही विपक्ष में इकलौती आवाज हैं, जो प्रधानमंत्री नरेंद्र मोदी को चुनौती दे रहे हैं। सूत्रों का कहना था कि पार्टी के कई राज्यसभा सदस्यों की इस मांग पर सोनिया गांधी की कोई प्रतिक्रिया नहीं आई।

गत 11 जुलाई को सोनिया ने कांग्रेस के लोकसभा सदस्यों के साथ डिजिटल बैठक की थी

और उसमें भी पार्टी के कई सांसदों ने राहुल गांधी को फिर से पार्टी अध्यक्ष की जिम्मेदारी देने की मांग की थी। बताते चलें कि पिछले साल लोकसभा चुनाव में कांग्रेस की हार के बाद राहुल गांधी ने इसकी नैतिक जिम्मेदारी लेते हुए अध्यक्ष पद से इस्तीफा दे दिया था। इसके बाद सोनिया गांधी को पार्टी का अंतरिम अध्यक्ष बनाया गया था।

सोनिया की अगुआई में हुई पार्टी के राज्यसभा सदस्यों की बैठक में पूर्व प्रधानमंत्री मनमोहन सिंह, राज्यसभा में नेता प्रतिपक्ष गुलाम नबी आजाद, कांग्रेस के संगठन महासचिव केसी वेणुगोपाल, वरिष्ठ नेता अहमद पटेल, दिग्विजय सिंह, जयराम रमेश और कई अन्य राज्यसभा सदस्य मौजूद थे।

सूत्रों के अनुसार, इस बैठक में कोरोना महामारी से संबंधित हालात, मौजुदा राजनीतिक परिस्थिति, लद्दाख में चीन के साथ गतिरोध और अर्थव्यवस्था की स्थिति पर मुख्य रूप से चर्चा हुई। पूर्व प्रधानमंत्री मनमोहन सिंह ने अर्थव्यवस्था की स्थित पर अपनी बात रखी। बताते चलें कि राज्यसभा में कांग्रेस के सदस्यों की संख्या 40 है, जबकि लोकसभा में पार्टी के सांसदों की संख्या 52 है।

# जमानत आदेश में संशोधन के अनुरोध की हार्दिक की याचिका खारिज

अमदाबाद, ३० जुलाई (भाषा)।

अमदाबाद की एक सत्र अदालत ने गुरुवार को गुजरात कांग्रेस ने महाराष्ट्र माध्यमिक स्कूल के कार्यकारी अध्यक्ष हार्दिक पटेल की जमानत की शर्त में संशोधन करने का अनुरोध वाली याचिका को खारिज कर दिया। इस शर्त के तहत अदालत की पूर्व अनुमित के बिना उनके राज्य से बाहर जाने पर रोक है। गुजरात सरकार की आपत्तियों को ध्यान में रखते हुए अतिरिक्त सत्र न्यायाधीश बीजे गणात्रा ने पटेल की याचिका को में है। खारिज कर दिया।

अदालत ने उस शर्त को बरकरार रखा कि कांग्रेस नेता जब भी बोर्ड के नतीजे की घोषणा की गई। राज्य से बाहर जाना चाहें, वे अदालत से संपर्क कर सकते हैं। वर्ष 2015 में पटेल के खिलाफ दर्ज राजद्रोह के मामले में सुनवाई के दौरान अनुपस्थित रहने के चलते इस अदालत ने उनके खिलाफ गैर जमानती वारंट जारी किया था। पटेल की गिरफ्तारी के बाद जनवरी में उन्हें जमानत दी गई थी।

जमानत इस शर्त पर दी गई थी कि कांग्रेस नेता अदालत की पूर्व अनुमित के बिना गुजरात नहीं छोड़ेंगे। हाल ही में प्रदेश कांग्रेस के कार्यकारी अध्यक्ष के रूप में नियुक्त किए जाने के बाद 26 वर्षीय पटेल ने अपनी जमानत के आदेश से शर्त हटाने की मांग करते हुए अदालत का दरवाजा खटखटाया। उन्होंने तर्क दिया कि नई जिम्मेदारी के चलते उन्हें अक्सर राज्य से बाहर जाना पड़ेगा। हालांकि, राज्य सरकार ने पटेल की याचिका का विरोध करते हुए कहा कि उनके कारण पहले ही राजद्रोह के मामले की सुनवाई में देरी हुई।

नारायण नखाटे ने बताया. 'धनंजय नियमित तौर पर स्कूल जाता था और जब भी समय मिलता था पढाई करता था। मैं भी खेत के साथ ही अन्य जगहों पर काम करता हुं।'

# उच्च शिक्षा आयोग के तहत चार स्वतंत्र निकाय करेंगे काम

जनसत्ता ब्यूरो नई दिल्ली, 30 जुलाई।

केंद्रीय मंत्रिमंडल की ओर से बुधवार को मंजूर की गई नई शिक्षा नीति में उच्च शिक्षा के लिए एक ही नियामक संस्था बनाने का प्रावधान किया गया है। इसके तहत वर्तमान में कार्य कर रही विश्वविद्यालय अनुदान आयोग (यूजीसी), अखिल भारतीय तकनीकी शिक्षा परिषद (एआइसीटीई) आदि को एक साथ लाकर भारतीय उच्च शिक्षा आयोग (एचईसीआइ) की स्थापना की जाएगी। यह आयोग ही नियमन, प्रत्यायन, अनुदान और अकादिमक मानकों को निर्धारित करेगा। इसके लिए आयोग के अंतर्गत चार स्वतंत्र और सशक्त निकाय कार्य करेंगे

जिनमें राष्ट्रीय उच्च शिक्षा नियामक परिषद, राष्ट्रीय

प्रत्यायन परिषद, उच्च शिक्षा अनुदान परिषद और

राष्ट्रीय उच्च शिक्षा नियामक परिषद विधि और चिकित्सा शिक्षा को छोड़ कर उच्च शिक्षा के लिए एकल नियामक होगा। इसके तहत अध्यापक शिक्षा भी आएगी। दूसरा निकाय होगा राष्ट्रीय प्रत्यायन परिषद। वर्तमान में उच्च शिक्षण संस्थानों को मान्यता देने का काम राष्ट्रीय मूल्यांकन एवं प्रत्यायन परिषद (नैक) स्वतंत्र रूप से करती है। अब राष्ट्रीय प्रत्यायन परिषद इस कार्य को एचईसीआइ के तहत करेगी। यह परिषद प्रत्यायन के नियमों में भी बदलाव

करेगी। तीसरा, उच्च शिक्षा अनुदान परिषद पारदर्शी तरीके से उच्च शिक्षण संस्थानों के अनुदान और वित्त की आवश्यकताओं के लिए कार्य करेगी। चौथा निकाय यानी सामान्य शिक्षा परिषद उच्च शिक्षा में सीखने के परिणाम जिसे स्नातक गुण भी कहा जाता है, को तैयार करेगी। इसके अलावा यह परिषद एक राष्ट्रीय उच्चतर शिक्षा योग्यता फ्रेमवर्क तैयार करेगी।

# मामले में 10 गिरफ्तार

अगरतला, ३० जुलाई (भाषा)

सामान्य शिक्षा परिषद शामिल हैं।

त्रिपुरा के खोवई जिले में एक किशोरी से सामूहिक बलात्कार के आरोप में दस लोगों को गिरफ्तार किया गया है।

पुलिस उपमहानिरीक्षक (उत्तरी क्षेत्र) सौमित्र धर ने कहा कि लड़की ने अपनी शिकायत में कहा है कि 21 जुलाई को जिले के खासियामंगल क्षेत्र में पांच लोगों ने उसे जंगल में ले जाकर बलात्कार किया। सौमित्र धर ने कहा कि इस मामले में पुलिस के मृद्दे पर अपनी पार्टी के नेताओं की आलोचना की है। ने 10 लोगों को गिरफ्तार किया है। इनमें से तीन को बलात्कार और बाकी को आरोपियों को सहयोग देने और शरण देने के मामले में गिरफ्तार किया गया है। पुलिस उपमहानिरीक्षक ने बताया कि सिपाहीजाला जिले के दो लोगों को आरोपियों का सहयोग करने के चलते गिरफ्तार किया गया। वहीं बाकी को इससे पहले गिरफ्तार किया गया था।

पुलिस ने बताया कि इस मामले में दो अन्य आरोपी फरार हैं और उनकी गिरफ्तारी के लिए तलाश जारी है। बलात्कार की इस घटना के एक हफ्ते बाद विश्वविद्यालय और कॉलेज के छात्रों का एक समृह महिलाओं के खिलाफ अपराध रोकने और इस तरह के मामले में तेजी से न्याय देने और आरोपी को कड़ी सजा देने की मांग कर रहा है। दरअसल त्रिपुरा विश्वविद्यालय के असमीरा देबबर्मा ने 'स्टैंड अगेंस्ट रेप (बलात्कार के खिलाफ आवाज उठाएं) नाम से एक समूह बनाया है जिससे 25 विद्यार्थी जुड़े हैं।

# किशोरी से बलात्कार उपचुनाव में तांत्रिकों की मदद को लेकर मप्र के कांग्रेस विधायक ने की अपने ही नेताओं की आलोचना

भोपाल, ३० जुलाई (भाषा)।

कांग्रेस नेता दिग्विजय सिंह के छोटे भाई एवं पार्टी विधायक लक्ष्मण सिंह ने मध्य प्रदेश में 27 विधानसभा सीटों पर आगामी उपचुनाव में कथित तौर पर तांत्रिकों की मदद लेने

सिंह ने इस संबंध में कांग्रेस नेताओं पर कटाक्ष करते ्हुए गुरुवार को ट्वीट किया, 'हम कांग्रेस के साथी, भाजपा, संघ की विचारधारा को निरंतर कोसते हैं, मैं भी उनकी विचारधारा से सहमत नहीं हूं। परंतु कांग्रेस की विचारधारा कहां लुप्त हो गई कि चुनाव में हमें 'दुष्ट' तांत्रिक बाबाओं की मदद लेनी पड़ रही है?' दरअसल पिछले दिनों कंप्यूटर बाबा (नामदेव त्यागी) का अन्य बाबाओं के साथ पूरे प्रदेश में एक वीडियो वायरल हुआ था जिसमें वह भजन मंडली के साथ मार्च महीने में कांग्रेस एवं विधायक पद छोडकर भाजपा में शामिल होने वाले नेताओं के खिलाफ भजन गा रहे हैं।

इस संबंध में कंप्यूटर बाबा से संपर्क करने पर मालूम हुआ कि वह फिलहाल इंदौर में एक अनुष्ठान करा रहे हैं। फोन पर उनके सहयोगी ने कहा कि बाबा व्यस्त हैं और अगले कुछ घंटे बात नहीं कर सकते। प्रदेश में पूर्ववर्ती कांग्रेस सरकार ने कंप्यूटर बाबा को मां नर्मदा, मां क्षिप्रा और मंदाकिनी नर्दी न्यास का अध्यक्ष नियुक्त किया था।

# बाबरी मामला : दस्तावेजी सबूत पेश करने के लिए दिया एक हफ्ते का समय

सीबीआइ की विशेष अदालत ने 1992 के बाबरी विध्वंस मामले में आरोपी पवन कुमार पांडेय और 16 अन्य को आरोपों के प्रत्यत्तर में दस्तावेजी सबत पेश करने के लिए गुरुवार को

एक हफ्ते का समय दिया। विशेष न्यायाधीश एसके यादव ने शेष बचे 15 अभियुक्तों से भी कहा कि अगर उनके पास बचाव में कोई सबूत है तो वे उसे अगले सप्ताह शुक्रवार तक पेश करें। पांडेय और अन्य ने विशेष अदालत के सामने दस्तावेजी सबृत पेश करने के लिए 15 दिन का समय मांगा था

लेकिन अदालत ने केवल सात दिन का समय दिया क्योंकि सुप्रीम कोर्ट के निर्देशों के अनुसार सुनवाई 31 अगस्त तक पूरी की जानी है। अदालत ने आरोपी पाँडेय के जमानतदारों को भी नोटिस जारी किया है क्योंकि अदालत की ओर से उन्हें पहले ही घोषित अपराधी करार दिया जा चका है।
