कोरोना संक्रमण की सबसे खतरनाक लहर का असर धीमा हुआ है। बुधवार को दिल्ली में संक्रमण दर गिरकर 27 फीसद से नीचे आ गई है। बीते 24 घंटे में 20,960 नए संक्रमण के मामले सामने आए हैं और 311 मरीजों की कोरोना संक्रमण की वजह से मौत हुई है। इस दौरान 19,209 मरीज ठीक होकर वापस अपने घरों को भी लौटे हैं।

4,834 और कोविड स्वास्थ्य केंद्र में 85 बिस्तर खाली हैं।
